From its inception in 1920, the League has been a leading voice for changes, strengthening our democratic system at every level of government. The League will continue to take on the challenges of a new century, reforming the governmental system and engaging the citizens - - so that ***everyone votes and every vote counts***.

Because of the League's reputation for thoroughness - - and for our nonpartisanship, we are listened to on national, state, and local issues.

Our services include:

VOTERS SERVICE

Includes candidate forums and publications, such as election time *VOTERS GUIDES* and a pamphlet on *VOTING IN TEXAS* that promote informed involvement in the election process. There are several other publications and activities available from the National and State Leagues, including educational conferences.

PROGRAM

Consists of study and action. It rests on grassroots-level input and includes program planning and efforts to reach agreement on issues, with a range of advocacy activities to seek passage of these positions. In the past the local chapter has studied the public library, city boards & commissions, environmental issues, and gov't ethics. At present, as part of the State League, we are participating in its sponsored studies.

COMMUNITY RELATIONS

In addition to the above activities, the League encourages cooperation with other community organizations, and actively contacts the City Council & State Legislature concerning items that affect Wichita Falls, and the State.

LWV-Wichita Falls is an integral part of LWV-United States and LWV-Texas.
